Mr John Smith, Gentleman

I first came across the name of Mr John Smith in reference to him buying Abbot's House. In 1795 he is reputed to have bought the house from Anne Clarke's executors. He then apparently gave the house to his son Thomas (husband of Sarah Smith). I was curious about such generosity and wanted to find out more.

The parish records for St Lawrence, Abbots Langley confirm that on 13th June 1797 Mr John Smith, 63 years, was buried. The title 'Mr' had great significance at that time. It indicated that he had land or fortune, so that he held status above the rest of the untitled members of his society. Mr John Smith, Gentleman would certainly have viewed himself above John Smith, Ploughman. His son Thomas also carried this status, being buried as Mr Thomas Smith.

Unfortunately there I became stuck, as I found no record of the birth of either father or son. The parish records for St Lawrence also do not hold information about John Smith's marriage.

More information was forthcoming from Sun Fire insurance policies held in the London Metropolitan Archives. Here I found two policies separated by 10 years.

In the 1781 Sun Fire insurance policy I found John Smith, Maltster & Mealman, Abbots Langley. He was insuring a 'house and offices only adjoining in the tenure of Frances Knowles, a Barn Stable and Hogsty and Brewhouse'. I have interpreted this to possibly be the Unicorn pub.

In 1791 I now found that John Smith was now referring to himself as a Hertfordshire Gentleman. In this policy he was covering far more properties in Kitters Green, Sarratt and Bovingdon, as well as the Unicorn pub. I assume he owned these properties, as he was insuring them. Certainly he seems to have shed the title of Mealman and Maltster.

The final historical evidence that I hold for Mr John Smith is from the Hertfordshire Militia Ballot Lists. The Napoleonic War caused concern about a possible invasion of England from France. The Militias were formed from volunteers, who undertook basic military training. Hertfordshire is lucky to still have extensive lists. In them I found various entries. In 1758 I found John Smith Abbots Langley Farmer Mr. 1769 John Smith South End Gentleman. In 1778 for South End there are various entries as 'Servant to Mr. Smith'. I am not sure where South End, Abbots Langley refers to and John Smith is quite a common name!

I offer what little information I have found in the hope that someone in the future will be able to fill in the missing parts of John Smith's life-story.
